Award: Meritorious Unit Commendation

Period of service: 16 December 2011 to 22 October 2012

Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. During the period 16 December 2011 to 22 October 2012, the 822d Transportation Detachment performed exceptionally while in support of Operation Enduring Freedom. This unit operated the airfield arrival and departure control group and processed and tracked all cargo inbound and outbound from Kandahar Airfield, Afghanistan. The Soldiers of this unit operated eight separate sites, processed over 390 million pounds of sustainment and retrograde cargo as well as over 400,000 passengers both within and outside of Afghanistan. The units' mission execution and commitment to excellence set a new standard for Kandahar airfield air operations. The actions of the 822d Transportation Detachment are in keeping with the highest military traditions and reflect great credit upon the unit, the 257th Transportation Battalion, the Joint Sustainment Command-Afghanistan and the United States Army.
