Award: Meritorious Unit Commendation

Period of service: 19 July 2012 to 15 March 2013

Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. During the period 19 July 2012 to 15 March 2013, the 2d Battalion, 503d Infantry Regiment and the cited unit displayed exceptionally meritorious service while deployed in support of Operation Enduring Freedom. The units conducted sustained combat operations along with multiple named operations across Wardak Province, Afghanistan. The 2d Battalion, 503d Infantry Regiment and the cited unit's expertise in bringing decisive combat power to bear on the enemy while enabling the Afghan Nation Security Forces drastically increased the security in Wardak Province, Afghanistan. The Soldiers' efforts in maintaining freedom of movement on Highway One while strengthening 2d, 3d and 6th Kandaks of 4th Brigade, 203d Corps of the Afghan National Army extended well beyond the call of duty. The actions of the 2d Battalion, 503d Infantry Regiment and the cited unit are in keeping with the highest traditions of military service and reflect great credit upon the units, the 173d Airborne Combat Team, Regional Command-East and the United States Army.

The streamers will then be manufactured and sent to the U.S. Army Human Resources Command for automatic distribution to the units concerned. It is not the responsibility of HRC to replace streamers that are lost or damaged. Please refer to AR 840-10 for further guidance regarding the responsibilities of the unit concerning the display, care and disposition of the streamers.
